



CONTRACT AND PURCHASE AGREEMENT

Unique Poodles (Breeder) is happy that you (Buyer) have decided to add a new puppy to your family and want to ensure you that each puppy is in good health and free of disease at the time of delivery. We require that your new puppy be seen by a veterinarian of your choice within 48 hours of delivery so that we may honor our guarantee of a healthy puppy. If a problem is found at the time of examination, the Buyer may return the puppy along with a written report from the veterinarian explaining the problem. Buyer will then be entitled to a replacement puppy of equivalent value when one becomes available. We cannot guarantee against exposure to disease and viruses, we will find it necessary to VOID this contract if veterinary examination does not take place within 48 hours after delivery of your puppy. Your puppy will come with a health record showing dates of deworming and shots, which were provided by the Breeder to date.

Your puppy is also guaranteed against life-threatening congenital defect (heart, liver, kidney) until 1 year of age. If your puppy is determined by a veterinarian to have a congenital defect in the first year of life, Buyer may return the puppy along with the written veterinarian's report and will be given a replacement with the next available puppy of equal value. Should death occur within the first year, a necropsy must be performed by a licensed veterinarian. Once a written report is provided confirming cause of death to be a congenital defect, Breeder will provide a replacement with the next available puppy of equal value.

Your new puppy can become stressed by shipping, adjusting to a new home, change in diet, etc. Which can bring on problems including (but not limited to): Hypoglycemia, Coccidiosis/giardia, cold, URI, worms, ear mites, etc. Once the puppy leaves the Breeders, we have no control over his environment. The mentioned conditions are treatable and do NOT constitute a valid reason for returning the puppy to the Breeder for replacement.

NO REFUNDS will be provided. Should your new puppy meet the above conditions for return to the Breeder, REPLACEMENT ONLY of another puppy of similar value will be made when one is available. Returned puppies must be accompanied by all veterinary reports and vaccinations must be up to date. Shipping is at the expense of the Buyer; however, shipping of a replacement puppy will be at the expense of the Breeder.

All expenses incurred after the puppy leaves the Breeders care are the responsibility of the Buyer. This contract also does not provide any return or replacement provision for accidental injury. Accidents can happen and every effort should be made to ensure safe handling and a healthy, puppy-proofed environment in your home. NO guarantees are made as to size, color, personality, temperament or fertility as puppies are sold as pets only. Buyer also agrees to notify Breeder if they can no longer care for or keep the puppy. You agree that you will not take the puppy to a shelter or abandon the puppy. The puppy can always be returned to the Breeder at no cost to the Breeder.

This is a binding agreement between UNIQUE POODLES (Breeder) and you (BUYER)
